**INTERIM ENFORCEMENT ORDER**

---

**UPON THE CLAIM UNDER** the Enterprise Act 2002 ("EA02"); the Consumer Protection from Unfair Trading Regulations 2008 ("CPRs"); and the Unfair Terms in Consumer Contracts Regulations 1999 ("UTCCRs").

**AND UPON AN APPLICATION** by the Claimant dated 17 July 2012 for an interim enforcement order under section 218 EA02.

**AND UPON READING** those documents on the Court file recorded as having been read **AND UPON HEARING** Cairns Nelson QC for the Claimant and Rhodri Thompson QC for the Defendant(s) on 23 July 2012.

A handwritten signature or initials in black ink, located at the bottom left of the page.

**WHEREAS:**

1. The Claimant's application for an interim enforcement order ("Order") be granted in the terms set out herein.
2. The Defendants' product is London Olympic Games 2012 tickets.

**IT IS ORDERED THAT:**

3. The Defendants shall not (whether by their officers, employees, agents, associates or otherwise) continue or repeat the conduct described in paragraph 7 below.
4. The Defendants shall not (whether by their officers, employees, agents, associates or otherwise) engage in such conduct in the course of its business or another business.
5. The Defendants shall not (whether by their officers, employees, agents, associates or otherwise) consent to or connive in the carrying out of such conduct by another body corporate with which it has a special relationship (within the meaning of section 222(3) of the EA02).
6. The Defendants shall not within the meaning of section 222(2) EA02 use unfair commercial practices prohibited by the Consumer Protection from Unfair Trading Regulations 2008 ("the CPRs"), by representing that they can legally sell tickets to the London Olympic Games 2012 and that consumers who purchase from them will receive tickets allowing them entry to the London Olympic Games.
7. Within the European Economic Area the Defendants will:
  - i. Stop forthwith offering for sale London Olympic Games tickets on all the following websites (each a "Website" and together "the Websites"):

II. Stop forthwith selling London Olympic Games tickets on all the Websites;

III. Cease to enter into any unlawful agreement whereby consumers purchase London Olympic Games tickets from the Defendants on all the Websites;

8. Should the Defendants not comply with paragraph 7 within 24 hours from this Order, the OFT may instruct the Authoritative Registry Operator or Website Domain Reseller to Registry Lock and Redirect the domains of the infringing Website or Websites to a holding page.

9. This Order may be served on all defendants by service on Hogan Lovells or insofar as Hogan Lovells does not act for the First, Third and Fourth Defendants, this Order may be served on the First, Third and Fourth Defendants by a PDF copy being left at the First Defendant's address.

10. The Defendants to pay costs of this application to the Claimant to be assessed if not agreed.
