1. Introduction

The 2014 to 2020 European Structural and Investment Funds bring the European Regional Development Fund, European Social Fund and part of the European Agricultural Fund for Rural Development together into a single European Union Structural and Investment Funds Growth Programme for England supporting the key growth priorities of innovation, research and development, support for Small and Medium Sized Enterprises, low carbon, skills, employment, and social inclusion.

The Funds are managed by the Department for Communities and Local Government for European Regional Development Fund, Department for Work and Pensions for European Social Fund and the Department for Environment, Food and Rural Affairs for European Agricultural Fund for Rural Development. These Departments are the Managing Authorities for each Fund. In London, the Greater London Authority acts as an Intermediate Body for the European Regional Development Fund and European Social Fund programmes. In some other areas, Intermediate Bodies are being designated to undertake delegated tasks and functions (the assessment against selection criteria in relation to fit with local priorities). Unless stated otherwise, the term “Managing Authority” will apply to all these organisations. The Managing Authorities work closely with local partners who provide:

1. Practical advice and information to the Managing Authorities to assist in the preparation of local plans that contribute towards Operational Programme priorities and targets;
2. Local intelligence to the Managing Authorities in the development of project calls (decided by the Managing Authorities) that reflect Operational Programme and local development needs as well as match funding opportunities; and
3. Advice on local economic growth conditions and opportunities within the context of the Operational Programme and the local European Structural and Investment Fund Strategy to aid the Managing Authorities’ assessments at outline and full application stage.

This call is issued by the Department for Communities and Local Government and invites Outline Applications in respect of the European Regional Development Fund for England 2014 to 2020.

2. Call Context

On behalf of the national Growth Programme Board, the Department for Communities and Local Government (the Managing Authority) invites applications seeking European Regional Development Fund support under:

Priority Axis 4 Supporting the Shift to Low Carbon Economy in All Sectors

Investment Priorities:

- 4b** Promoting energy efficiency and renewable energy use in enterprises.
- 4f** Promoting research and innovation in, and adoption of, low-carbon technologies.

The European Regional Development Fund Operational Programme for England 2014 to 2020 sets out how the European Regional Development Fund will focus on investment to support economic growth and job creation. **Priority Axis 4** of the Operational Programme aims to move England's economy towards a low carbon model by reducing greenhouse gas emissions, increasing the share of renewable energy and enhancing the energy efficiency of homes businesses and transport.

Any application for funding will be required to clearly demonstrate that it meets the requirement of, and makes a meaningful contribution to, the delivery of the relevant Priority Axis of the [European Regional Development Fund Operational Programme](#).

In addition, applications will be expected to meet identified local development need, as expressed in the scope of this call and as set out in the [Gloucestershire Local Enterprise Partnership area](#) European Structural and Investment Funds Strategy.

Applicants are advised to familiarise themselves with the detail of the Operational Programme, local European Structural and Investment Funds Strategy and the relevant documentation listed in sections 5 through to 8 **prior to** submitting an Outline Application.

3. Scope of the Call

1. Scope

This call invites Outline Applications which support the delivery of **Priority Axis 4** of the European Regional Development Fund Operational Programme and responds to the local development need set out in the [Gloucestershire Local Enterprise Partnership area](#) **European Structural and Investment Funds Strategy**.

2. Local Development Need

Projects must deliver activity which directly contributes to the objectives of Priority Axis 4 of the Operational Programme, one or more of the relevant Investment Priorities and meet the **local development need** expressed in the table below.

LOCAL DEVELOPMENT NEED
<p>Local Economic Context :</p> <p>This call focuses on Investment Priorities 4b and 4f of the European Regional Development Fund Operational Programme and Thematic Objective 4 within Section 4 of the Gloucestershire Local Enterprise Partnership European Structural and Investment Funds Strategy.</p> <p>The Gloucestershire Local Enterprise Partnership European Structural and Investment Funds Strategy states Gloucestershire’s aim to become a national centre of excellence for innovation and learning in the energy sector. Recognising the potential impact climate change could have on the county, the strategy also lists support for energy conservation and low carbon generation as a key priority for investment.</p> <p>Gloucestershire already has a strong track record in the energy sector with some large innovative firms headquartered in the county, for example: Horizon, Ecotricity and Tidal Lagoon Power. Additionally, the county has examples of successful low carbon projects, such as the ‘Warm and Well Programme’ and the ‘Stroud Target 2015 programme’, as well as an exemplar network of installer businesses that provide energy-related services for homes and businesses.</p> <p>Gloucestershire is also home to innovation-strong higher education institutions and the county itself possesses environments, locations and businesses where new low carbon ideas may be tested, refined and potentially prepared for market. As identified in the Gloucestershire Local Enterprise Partnership European Structural and Investment Funds Strategy, Gloucestershire is especially well placed to deliver activities around solar, wind and tidal energy.</p> <p>However, the European Structural Investment Funds Operational Programme and the Gloucestershire Local Enterprise Partnership European Structural and</p>

Investment Funds Strategy cite evidence that small and medium sized enterprises typically exhibit low levels of awareness about the benefits of energy efficiency, in respect of clean technology and green business practices. Even after the success of previous projects in the county, this is still true of smaller businesses in Gloucestershire.

Additionally, the Gloucestershire Local Enterprise Partnership European Structural and Investment Funds Strategy highlights that, by 2011, growth in the county had slowed in comparison with other Local Enterprise Partnership areas, and that productivity had stagnated relative to the rest of the UK.

Innovation is frequently identified as one of the key drivers of growth and productivity, however the number of patents registered per 100,000 residents in Gloucestershire (a proxy for innovation) is broadly average relative to other Local Enterprise Partnership areas. In 2009, there were 12.9 patents per 100,000 residents, ranking the area 15th of the 39 Local Enterprise Partnerships. To move Gloucestershire to 10th place, the number of patents per 100,000 residents would need to double.

This call seeks to invest European Regional Development Funds in activities that utilise the knowledge of innovative firms headquartered in the county, learn from previous low carbon projects, and capitalise on the county's current innovation and local assets to:

- Promote and improve energy efficiency and the use of low carbon technologies/environmental goods and services within small and medium sized enterprises (investment priority 4b);
- Promote research and innovation in, and the adoption of, low carbon technologies (investment priority 4f).

Local Priorities:

Proposals should demonstrate alignment with local development need and priorities including:

- Demonstration that proposed **investment priority 4b** activities will deliver one or more of the following:
 - A multi-channel (ie online, telephone, face-to-face), dedicated energy efficiency advisory service for a high percentage of Gloucestershire's eligible small to medium sized enterprises;
 - Intensive energy efficiency demonstration and support services for European Regional Development Fund eligible, high growth potential businesses;
 - The application of existing knowledge and technologies to improve sustainability and encourage adoption of low carbon technologies / environmental goods and services;
 - An increase in the number of businesses that pilot or install and implement low carbon technologies and approaches / environmental goods and services.

Overall, activities proposed in support of investment priority 4b should be for eligible small and medium sized enterprises, achieving a reduction in energy costs, an

increase in positive energy saving attitudes and behaviours, and ultimately resulting in carbon savings.

- Demonstration that proposed **investment priority 4f** activities will deliver one or more of the following:
 - Better mechanisms for knowledge exchange; forging stronger links between businesses and innovation-strong higher education institutions and developing business-to-business, low carbon / environmental goods and services, and specific innovation networks;
 - Research into improving existing and developing new renewable and low carbon technologies / environmental goods and services, including specific research and development of innovative solar, wind or tidal energy technology;
 - Support for companies to develop new low carbon technologies / environmental goods and services, including access to facilities to allow companies to trial and test new products, and development of the supply chain and local market.

Overall, activities proposed in support of investment priority 4f should demonstrate links with relevant research institutions and support eligible small and medium sized enterprises to develop and introduce to market innovative low carbon technologies / environmental goods and services.

- Where relevant, a need to align activity with the Growth Hub, including:
 - Understanding plans for the roll out of a Growth Hub network across Gloucestershire;
 - Ensuring proposed activities complement existing and planned Growth Hub business support, for example the 'Navigator' and 'Guide' services, outlined within the Gloucestershire Local Enterprise Partnership European Structural and Investment Funds Strategy, and activity to build innovation capacity within small and medium sized enterprises (the focus of a concurrent call under priority axis 1);
 - A need to address the challenge of reaching businesses, both new to the support environment and those not targeted through previous programmes;
 - Offering equal consideration to ensuring businesses located in rural Gloucestershire, as well as in the business centres / market towns, can access innovation support.

Applicants are invited to:

- Explain how proposed activities will complement and add value to, rather than duplicate, existing low carbon programmes and activities within Gloucestershire;
- Refer to the ['Priority Axis 4: Supporting the Shift Towards a Low Carbon Economy in All Sectors; Guidance Advice'](#);
- Provide clear justification and evidence for why activities, the product / service or the approach to implementation, proposed under investment priority 4f are considered to be innovative;

- Clearly identify which investment priority (either or both) proposed activities will support (up to £2,200,000 is available for investment priority 4b and up to £1,100,000 for investment priority 4f);

There are concurrent relevant calls being issued in the Gloucestershire Local Enterprise Partnership area under:

- Priority Axis 1; supporting businesses in building innovation capacity;
- Priority Axis 3; supporting core Growth Hub services, providing start-up business support and providing coaching for businesses in high growth potential sectors.

3. Operational Programme Investment Priorities

Applications must specify the activities to be delivered and are expected to directly contribute to **one or more** of the following Investment Priorities:

Investment Priority	4b – Promoting energy efficiency and renewable energy in enterprises.
Specific Objectives	Increase energy efficiency in particular in Small and Medium sized Enterprises, including through the implementation of low carbon technologies.

Investment Priority	4f – Promoting research and innovation in, and adoption of, low-carbon technologies.
Specific Objectives	Increase innovation in, and adoption of, low carbon technologies.

Indicative Actions

Under this investment priority indicative actions to be supported by European Regional Development Fund may include:

- Research and Development, innovation and supply chain work for low carbon technologies and materials, including, wave and wind energy, smart grids, distributed generation, solar and photovoltaics, heat networks, heat pumps and low carbon heat for energy intensive industries
- Research underpinning carbon capture and storage, taking account of the restrictions laid down in Article 3.3.b of the European Regional Development Fund
- Technology centres of excellence and test facilities, including relevant Catapult centres
- Renewable technologies in the United Kingdom renewable energy roadmap
- Research, development, demonstration and adoption of technologies and systems that support low-energy transport and accelerate the establishment of new technologies such as low emissions vehicles (electric, hybrid and hydrogen)
- Knowledge transfer with Higher Education/Further Education institutions and Businesses
- Supporting low carbon tech start-ups and greater commercialisation of low carbon products and processes
- Developing financing methods that encourage the adoption of proven low carbon technologies and generate long-term financial savings
- Demonstration and deployment of decentralised renewable energy technologies
- Research, development and innovation and supply chain development for low carbon and resource efficient technologies and materials (including small scale pilot programmes that test the market with new low carbon solutions and the use of secondary materials).

4. Required Outputs under this Call

Projects must deliver against the Priority Axis 4 outputs of the European Regional Development Fund 2014 to 2020 Operational Programme. For projects coming forward under this call the expected outputs and results are:

Applicants will need to demonstrate how the eligible activity, funded by the European Regional Development Fund, will achieve the outputs committed to within the proposal. The application should clearly state the methodology used to determine the levels of outputs proposed.

All operations will be required to report regularly on progress toward achievement of targets. This will need to include both quantitative and qualitative data relevant to the appropriate geographical areas. Applicants will need to explain how they will collect and record this information to maintain a fully evidenced audit trail. It should be noted that if an operation fails to deliver contracted outputs, a performance penalty may apply.

5. Application Process & Prioritisation Methodology

There are two stages to the European Regional Development Fund application process;

- Outline Application and, if successful
- Full Application.

Acceptance of an Outline Application to progress to full application stage does not in any way indicate or constitute an offer of European Regional Development Fund grant.

Applicants must fully complete the [Outline Application](#) which will be assessed by the Managing Authority against the national [Selection Criteria](#). Where an Intermediate Body has been designated to undertake delegated tasks and functions, the Intermediate Body will undertake the assessment of some selection criteria in relation to fit with local priorities.

Outline Applications will be assessed in two stages, Gateway assessment and Core assessment.

Gateway assessment considers:

- applicant eligibility;
- activity and expenditure eligibility; and
- fit with the National Operational Programme and the local development need set out in section 2.

Proposals that fail the Gateway assessment undertaken by the Managing Authority will be rejected. Proposals which pass the Gateway assessment will then be assessed against the Core assessment criteria:

- Strategic Fit
- Value for money
- Management and control
- Deliverability
- Compliance
 - Procurement
 - State Aid
 - Publicity requirements
- Cross cutting themes
 - Environmental sustainability
 - Equal Opportunities

Having assessed projects against these criteria the relevant Local Economic Partnership Area European Structural and Investment Fund Sub-Committee will advise the Managing Authority or Intermediate Body as relevant on the contribution to local economic growth conditions and opportunities within the context of the Operational Programme and local European Structural and Investment Fund Strategy to aid the Managing Authority's assessments (at outline and full application stage).

Please note that the Managing Authority's decision is final and there are no appeals. If you wish to complain about the calls and application process, please follow the

6. General Information

1. National Eligibility Rules

When developing an application, Applicants must refer to the [National Eligibility Rules](#) setting out the requirements of the 2014-2020 European Regional Development Fund Programme. It is the responsibility of the Applicant to ensure that the Rules are adhered to both at application stage and following approval. Failure to do so can lead to financial penalties leading to recovery of up to 100% of grant. Applicants are strongly advised to seek specialist advice if in doubt on any requirement.

European Regional Development Fund eligibility rules apply to **all** project spend within the eligible costs, including match funding.

The European Regional Development Fund is governed by European regulations and national rules. Applicants are advised to familiarise themselves with the relevant documentation, (Section 8 Key Document refers) prior to submitting an Outline Application. If successful, Applicants will enter into a Funding Agreement and must abide by the standard terms and conditions contained therein. Applicants are therefore strongly advised to read these terms and conditions to ensure that they are able to enter into such an agreement prior to responding to the call. Once a Funding Agreement has been issued it should be signed and returned within 30 days, unless otherwise agreed with the Managing Authority.

2. Eligible Applicants

Section 4 of the [National Eligibility Rules](#) sets out who is eligible to apply.

Applicants must be legally constituted at the point of signing a Funding Agreement. If the application is approved the Applicant organisation will enter into a legally binding Funding Agreement and therefore will carry the liability for ensuring that the terms and conditions of the Funding Agreement are met.

If there is more than one organisation applying for the funds, a lead organisation must be selected to become the Applicant with the remaining organisation(s) acting as Delivery Partner(s). In this situation the Applicant would be responsible and liable for the Delivery Partner(s) and ensuring the project is operating compliantly.

During the application process the Managing Authority will consider the Applicant's track record, both positive and negative. If the Applicant has been involved in the

delivery of previous European grants and any irregularities have been identified, the Managing Authority will expect to see how and what steps have been taken to ensure that the risk of further irregularities in the future is mitigated. It is acknowledged that some organisations will be new to European Structural and Investment Funds funding and will not have a track record.

3. Contribution Rate & Match Funding

European Regional Development Fund is normally expected to intervene where no other funding can be obtained (i.e. the funder of last resort). The level of European Regional Development Fund awarded will be the minimum in order for the project to proceed.

The maximum Contribution Rate is 50% of the total eligible project costs subject to State Aid regulations.

The remaining 50% or more must come from other eligible sources as specified under section 6 of the National Eligibility Rules. Applicants will need to demonstrate that they have eligible match funding in place for the balance of costs. Other European Union funds cannot be used as a source of match funding.

European Regional Development Fund investment is limited by State Aid regulations and where the award of European Regional Development Fund would constitute State Aid the European Regional Development Fund grant rate may fall below the 50% maximum.

European Regional Development Fund is paid quarterly in arrears and expenditure must be defrayed prior to the submission of any Grant claims. Applicants may be asked to demonstrate how they are able to cash flow the operation.

4. Project Timescales

European Regional Development Fund funding will normally be approved for three years, however the Managing Authority reserves the right to extend the contract term in exceptional circumstances.

Projects approved through this call are expected to:

- Submit a detailed and complete full application within three months of formal selection at outline stage. Projects which fail to meet this deadline may be deselected,
- Commence delivery (defraying European Regional Development Fund eligible costs) within three months of formal approval. Projects which fail to meet this deadline may be deselected, and
- Be completed by June 2023.

5. Capital Projects

Applicants seeking European Regional Development Fund to support a capital project (i.e. land and/or property) will need to meet Building Research Establishment Environmental Assessment Method or Civil Engineering Environmental Quality Assessment 'Excellent' for new builds and 'Very Good' for refurbishments.

Applicants will need to provide evidence of how they will achieve the rating required (unless otherwise agreed with the Managing Authority).

Applicants will need to demonstrate that they have the rights and permissions to undertake the project and must provide:

1. Proof of current interest in the land and/or property, which includes evidence of the freehold ownership or any lease arrangements that may be in place; and
2. Evidence of the approval of any planning permission, or in certain circumstances a clear statement on the process for securing such consents and any risks to the project.

Royal Institute of British Architects Stage D costs must be supplied with the Full Application and be certified by an independent Quantity Surveyor and Land/Property contributions certified by a Real Estate Valuation expert who are current and chartered members of the Royal Institute of Chartered Surveyors/ Chartered Institute of Builders or equivalent body.

Successful Applicants will be required to provide security to the Managing Authority in the form of a Legal Charge and/or Deed of Covenant over the land and/or property. Applicants will be responsible for registering the charge at their own cost.

6. Cross Cutting Themes/Horizontal Principles

All applications received under this call should demonstrate how the Cross Cutting Themes have been addressed in the project design and development. Cross Cutting Themes for European Regional Development Fund are 'equality and anti-discrimination' and 'sustainable development'. Further information is available in the [European Regional Development Fund Operational Programme](#).

7. Additionality, Duplication and Displacement

Additionality is a core principle of European Regional Development Funding. Applicants must be able to demonstrate that the activity paid for out of European Regional Development Funding adds value to new or existing activity. Projects need to demonstrate that without the support of European Regional Development Funding the activity would not have taken place.

European Regional Development Funding cannot support activities that duplicate existing provision/services within the region.

Applications need to identify and evidence how the beneficiaries will use the service and demonstrate that the project does not displace other activity available in the market place.

8. State Aid & Revenue Generation

Applicants are required, in the Outline Application, to provide a view on how their proposal complies with State Aid law. Applicants must ensure that projects comply with the law on State Aid.¹ Grant funding to any economic undertaking which is State Aid can only be awarded if it is compatible aid, in that it complies with the terms of a notified scheme or is covered by the De Minimis Regulation. Guidance for Grant Recipients, explaining more about [State Aid](#), is available; it is important that Applicants take responsibility for understanding the importance of the State Aid rules and securing their full compliance with them throughout the project, if it is selected into the Programme.

The Managing Authority is not able to give legal advice on State Aid. It is the responsibility of the Applicant to ensure that the operation is State Aid compliant.

Where the Applicant does not perceive that there is any State Aid, it should state whether or not it considers Articles 61 and 65(8) of regulation 1303/2013 to apply. Article 61 refers to monitoring revenues generated after completion of the project, and Article 65(8) how to deal with differences in the forecast and actual revenues at the end of the operation. This revenue should be taken into account in calculating eligible expenditure. The details of this will be tested at the full application stage.

9. Funding Agreement

The Funding Agreement is a standard, non-negotiable and legally binding document. Any successful Applicant will be subject to the terms and conditions contained within this agreement. Applicants are strongly advised to seek relevant advice to ensure that they would be able to enter into and abide by the terms of the Funding Agreement.

¹ Article 107(1) of the Treaty on the Functioning of the European Union provides that: "Save as otherwise provided in the Treaties, any aid granted by a Member State or through state resources in any form whatsoever which distorts or threatens to distort competition by favouring certain undertakings or the production of certain goods shall, in so far as it affects trade between Member States, be incompatible with the internal market."

Applicants are advised that additional provisions and securities may be included within the Funding Agreement to protect the investment. Detailed advice will be given if appropriate at the Full Application stage.

Failure to meet any of the conditions of the Funding Agreement or the commitments within the application will result in claw back of the Grant (which may include interest).

10. Procurement

All costs claimed by the Applicant (Grant Recipient and/or Delivery Partner(s)) must be recovered on an actual cost basis. Other costs must be procured in line with National (including [Public Procurement Regulation 2015](#)) and European Union regulations. Procurement will be subject to audit and verification and any irregularity will result in financial penalty of up to 100% of the grant paid. Robust and transparent procurement is required to ensure that Grant Recipients:

- Consider value for money;
- Maximise efficient use of public money; and
- Maintain competitiveness and fairness across the European Union.

It is **strongly recommended** that Applicants seek and follow legal advice in respect of procurement requirements. Procurement irregularities remain the most substantive cause of error and clawback of grant.
